# (b) EXECUTIVE DIRECTOR'S REPORT

i. Elders Affordable Housing Strategy – Dwayne provided Council with a "draft" "Elders affordable housing and continuum of care strategy" for Nipissing First Nation for their review. He informed Council that this is only a draft document. The Nursing Home option is still being looked into but the options in this strategy would be worked on in the meantime.

- ii. NFN Solar LP Council was informed that this solar project is moving forward with the installation of solar panels on four NFN's buildings; Lawrence Commanda Health Centre, Small Business Centre, Seniors Complex and Nbisiing Secondary School. Tenders for the projects will be released in the near future.
- iii. Northern Ontario Business Awards Council was informed that Young Forestry, a NFN member business, will be receiving the Northern Ontario Business Award to be presented on October 3, 2013 in North Bay. Council approved the purchase of two tickets for family members of Brian Young to attend.

Council was informed that the fire trucks were parked in lessee's driveway's rather than in the Fire Hall to host a yard sale during the pow wow weekend, and this caused concern should an emergency have come up.
