

Recreation Reimbursement Policy

PURPOSE:

This fund was established to assist families and encourage a healthy, active lifestyle and promote growth in recreational activities to the children of Nipissing First Nation.

Recreation reimbursement for registration costs will be granted up to a maximum of \$500/year (April 1 – March 31) for each child/youth who is a registered member Nipissing First Nation Member.

DEFINITION:

Recreation "includes any extra-curricular activity including performance arts and/or individual sports".

PROCESS:

Requests for assistance must include the **original receipt** outlining the cost for the activity, and submitted to the Recreation Program. All requests will be considered using the following criteria:

- 1. Application forms for the Recreation Reimbursement Fund will be required for all requests.
- 2. The request must be sent to the recreation department.
- 3. Receipt must indicate the child's name, business/sport organization type, and amount paid for that child (amount per child must be indicated if combined on one receipt).
- 4. To be eligible the child's age must be 17 years of age or younger.
- 5. Approval will be granted for the registration of children to join organized teams, groups or recreational activities.
- 6. Parents must first pay the registration fee(s) then submit receipt(s) to the recreation department for reimbursement.
- 7. Payment will be made to the parent.

In the event of an exceptional request, the request will be brought to the attention of Council for consideration.

NOTE: This fund is available to all band members providing that they have tried all other avenues available to seek coverage.

What is the purpose of the Recreation Reimbursement Fund?

The purpose of the Recreation Reimbursement Fund is to assist families and encourage the healthy, active lifestyle and promote growth in recreational activities to the children of Nipissing First Nation. Eligible activities include:

- Sports and Recreation
- Arts

The Fund is open to children and youth who are registered members of Nipissing First Nation, aged 17 and under.

Recreation reimbursement will be granted for registration costs up to a maximum of \$500/year (April 1 – March 31) for each child who is a registered Nipissing Band Member.

Other Important Information

- The request must be sent to the recreation department.
- Receipt must indicate the child's name, business/sport organization type, and amount paid for that child (amount per child must be indicated if combined on one receipt).
- To be eligible the child's age must be 17 years of age or younger.
- Parents must first pay the registration fee(s) then submit the fully paid receipt(s) for reimbursement (up to a maximum of \$500/per year / per child).
- Once receipts are submitted payment will may take up to 30 days to be reimbursed

Eligibility Criteria

- Child/Youth must be a registered member of Nipissing First Nation residing on or off reserve
- 2. Beneficiary youth must be 17 years of age or younger at the time of activity.
- Original receipts are required to apply.

Allowable Funding Limit

Funding limit for the fund/child/year is \$500.
