(a) Cannabis Forum Report – Sept 24

Councillor Rick Stevens provided written briefing notes regarding the Cannabis Forum/Conference he and Chief McLeod attended. Concerns raised regarding the running of the conference include:

- Non-Licensed Cannabis retailers permitted onsite during a "Governance meeting."
- Isadore Day, allowed to Proxy for panel discussions need to define protocol/rules, Chief McLeod has requested that Proxy guidelines be added to the AN Fall Assembly agenda for discussion and clarification.
- Rick noted that the conference was chaotic until Chief McLeod took control and brought the room to order.

Chief McLeod confirmed that he would be in Yellowknife for the AFN Inland Working Group Meeting, during the same time as the AN Fall Assembly, at the beginning of November, in London and therefore will require someone to attend as Proxy.
