

Nipissing First Nation Electoral Officer's Nomination Meeting Report 2021

1. As of Election day there shall be 2,467 eligible voters.
2. The Nipissing First Nation is composed of one Chief and seven Councillors.
3. The election of Chief and Council is pursuant to the Nipissing First Nation Custom Election Regulations amended December 30th, 2020.
4. The notice of nomination meeting was:
 - a) Mailed to all eligible voters by April 21, 2021 to which Nipissing First Nation has an address for;
 - b) Posted by the 21st day of April, 2021, at the following locations:

Nipissing First Nation Administration offices, Lands Office, Health Officer, Daycare; Duchesnay Store, Eagles Nest, Necessities, How Convenient, North Shore convenience, Up Hill Variety, 17 Hour Convenience, Northern Convenience, Tim's Convenience;
 - c) Posted on the Nipissing First Nation web site and Nipissing First Nation facebook page and social media;
 - d) Promoted on the Garden Village and Duchesnay electronic bulletin boards and social media;
5. Mail-in nomination forms were also sent to all eligible voters by April 21, 2021 to which Nipissing First Nation has an address for;
6. The nomination meeting was held on the 21st day of May, 2021 via Zoom meeting protocols, from 7:00 pm to 9:00 pm.
7. There were approximately 58 eligible electors at the meeting and we received 29 nominations by mail-in.
