Soil Remediation Project

Community members may recall that work commenced in 2019 on the remediation of the former Nova Beaucage mine site in Yellek and the Ontario Ministry of Transportation (MTO) lands next to the Anishinabek Nation head office on Highway 17. The pandemic postponed that work and further delayed the contract award process. The Nipissing Miller Partnership was finally awarded the contract on July 24, 2023.


Since then, the contract administrator, Spector Group, has been leading monthly project meetings with representatives from Nipissing First Nation, Nipissing Miller Partnership, Indigenous Services Canada, and the Ontario Ministries of Transportation, Mines, and Environment, Conservation and Parks in preparation for the work to begin this year. These meetings focus on addressing all environmental considerations and

Elder Profile: Martha Clemens

Martha was born on March 3, 1918 to Mary Louise Juliette Green and Joseph Stevens. Martha's family lived on the French River at Sand Bay (where Martha was born) for the first six months of her life. Her grandparents were Joseph Green and Sophie Adam, and Joseph Stevens and Harriet Leclaire.



At Sand Bay, her family lived in a small log house. Their neighbours were Philix and Mary-Jane Lariviere, Frank and Jane Ducette, and Micheal and Celine Restoule (Victor Restoule's parents).

site-specific health and safety plans before any work to remove contaminated soil on NFN commences. Site preparation work is underway, and these operations are described in the Current Status section of this notice.

Background

A niobium ore processing mill operated for seven months in 1956 on Nova Beaucage Road in the community of Yellek. The land was returned to Nipissing First Nation after the lease expired in the early 1970s. The buildings were demolished in the 1980s, and only the concrete foundation remains.

Ore tailings from the processing mill were deposited at the mill site, and the former gravel borrow pit north of Highway 17 (next to the Anishinabek Nation head office), now owned by the MTO. Subsequently, material was removed from the sites to construct roadbeds, spread locally via grading activities around the site, and used as fill at private residences. All these residences were identified during the initial investigations and are part of the remediation plan.


The niobium tailings are considered a Naturally Occurring Radioactive Material (NORM). NORM is material found in the environment that contains radioactive elements of natural origin, such as uranium and potassium. The material will be removed to rehabilitate the sites for future use, including placing topsoil and seeding to restore them to a natural state. When NFN's Land Code was being developed, the Land Office included the contamination sites in the Individual Agreement between NFN and Indigenous Services Canada (ISC), which listed all outstanding legacy issues to be resolved, to ensure funding for the clean-up from ISC. Ontario was brought to the table through the advocation of Brent Trach, a former Environmental Officer with the Ontario Ministry of the Environment (MOE) who brought the contaminated land owned by the MTO to their attention.NFN, ISC and the MTO worked together over the years to get the project to this point and will continue to do so until it is completed.

Location of Disposal Site & NFN Work Site

The contaminated soil that will be removed from three work sites and the four identified private residences on NFN will be hauled to the Agnew Lake Tailings Management Area, located approximately 180km from Yellek, west of Sudbury.

Disposal Site: Agnew Lake Tailings Management Area

This federally regulated area is designed to receive radioactive material. The niobium material coming from NFN is less radioactive than the material currently stored at the Agnew Lake site and will be used as a "clean cap" for uranium tailings currently on site. An additional 12-15 cm of clean material and topsoil will be placed on top of the NORM and then revegetated.



Soil Remediation Project (con't)

Work Sites: Nipissing First Nation


<u>Site #1</u>: Former Nova Beaucage Mine Site -15,539 tonnes of contaminated material to be removed, along with concrete pad foundation.

<u>Site #2</u>: Section of Nova Beaucage Road at the corner of Ernest Avenue (18 tonnes) and the old Nova Beaucage Road allowance (7,080 tonnes). This road allowance was not part of the original project scope, but we are committed to cleaning up this area.



<u>Site #3</u>: MTO Lands east of Anishinabek Nation head office (11,409 tonnes)

These lands will be part of a future Additions to Reserve process and will become part of Nipissing First Nation lands.



<u>Private Residences:</u> 224 tonnes in total to be removed from four properties identified during initial investigations and included in the remediation plan. There are two residences in Garden Village, one in Yellek, and one in Duchesnay.

Current Status

The working days for the contract began on October 10, 2023. However, Nipissing Miller is awaiting the Ministry's approval of the health and safety plan before

commencing the excavation of contaminated material at any site.

Preliminary work completed by Nipissing Miller in the fall of 2023 included site clearing operations, preparation of staging areas, and a new parking area for the Anishinabek Nation office to provide a clear haul route. The project team also met with the residents of the four homes on NFN who have contaminated soil on their properties due to this material being used as fill in the 1980s, mainly for decks and firepits.

The operations for April 2024 consisted of completing the layout of the contaminated earth excavation limits, site preparation, and installing silt and security fencing at the former mine site (Site #1) and the MTO lands next to the Anishinabek Nation office (Site #3). Grubbing of non-contaminated materials at Site #1 and Site #3 is underway. The material from Site #1 is being hauled to a dumpsite located on Nova Beaucage Road where NFN's dozer is located.The grubbing work is for areas outside the contaminated earth excavation limits. This work must be completed before fence installation and is also required to develop areas for site facilities.

Excavation of the contaminated material on NFN is not expected to begin until July 2024, with the majority of the work being completed from August to November 2024. The completion date for the entire project is July 2025. However, Nipissing Miller will revise the schedule in late spring as more project details are finalized.

What to Expect

While this work is being completed on NFN during the summer and fall of 2024, community members can expect to see workers wearing Personal Protective Equipment (PPE), most likely including coveralls and masks. The Health and Safety Plan will be strictly followed to ensure worker safety when handling the contaminated material.

Soil Remediation Project (con't)

To ensure the safety of community members, we ask all residents to avoid work areas and respect fenced areas and posted signage. We appreciate your cooperation and are pleased that members will be able to enjoy these lands for many years to come once they are returned to a natural state.

A 5-meter clear zone from Lake Nipissing will be maintained to avoid environmental issues, and silt fencing will be used on all work sites. An Environmental Qualified Person (QP) hired by the Ministry will be on site to conduct tests to ensure that all contaminated material is removed.

Trucking will be used to transport the NORM material from the NFN excavation sites to the disposal area. Trucks will be securely tarped during transport. To ensure the trucks are clean prior to leaving the excavation area, all trucks will be scanned, cleaned via washing stations, and cleared to transport before leaving the site.

The washing or decontamination stations will be located on the excavation sites and will have a containment system in place to control and then dispose of all contaminated materials, including water. Water used within the decontamination process will be contained, tested, then treated for safe release with any contaminated materials being trucked away to a safe disposal site.

Once rehabilitated, the land use will be determined by the Chief and Council in future consultations with the community.

Community Open House / Information Session

A community open house/information session will be held on Wednesday, May 15, from 5 p.m. to 7 p.m. at Duchesnay Hall to provide historical information on the sites. Subject matter experts from NFN, Nipissing Miller, and the Ontario Ministry of Transportation will be available to answer questions from the community. Members of the project team will also be available to answer questions at the Health Fair in Garden Village on Thursday, May 30, from 2 p.m. to 5 p.m.

"Irresponsible, historic actions have left Nbisiing with scars of contamination. In the 1950s, the Nova Beaucage Mill was built east of Yellek to process ore containing niobium and uranium. After only seven months of operation, the mill closed. Everything was left on site, and the radioactive, contaminated land was given back to us without any remediation. Radioactive materials from the mill were also stored at the Ontario Ministry of Transportation's (MTO) abandoned sand pit on the north side of Highway 17. Unfortunately, ore stored at these sites was used for construction, landscaping, and roads in and around the community."

Elder Profile: Martha Clemens (con't)



When Martha's family moved from Sand Bay, they lived in many places around Lake Nipissing. In the spring, they lived where Mr. Leblanc and Mrs. Leblanc now reside (just outside of Garden Village). This is where the Stevens family lived for the couple of months they required to plant a garden. Once the garden was made, they would camp all summer at different locations to pick berries. Berries were plentiful back then; they sold many and preserved enough to supply the family until the next berry season.

They would travel to Sturgeon Falls to shop. Travel happened by canoe or steamboat in the summer, and by sleigh, horses, or foot in the winter. The families without horses would have to hire someone to take them. In early spring or late fall, dog teams were used because horses were too heavy for the ice. On the way to town, everyone would ride, but on the way home, with the wagon loaded with supplies, everyone walked.

After they picked berries all summer, they would return to the homestead, where they planted the garden. They would dig up the potatoes and other vegetables to prepare them for the winter ahead. All the veggies and berries were brought to their winter home at Wigwam Point.

They followed this pattern for approximately fifteen years.

Then, they moved to Hardy Bay for the next ten years that followed. Hardy Bay is situated approximately one mile between Sand Bay and Dokis Bay. They would travel to Dokis Bay by way of canoe to attend church services. In the winter, they would walk to church. Their house near Garden Village was sold and they planted the garden at Hardy Bay. Now, raspberries were so plentiful then that families from Dokis Bay and town would come to pick them. There were just two families at Hardy Bay. The other family was Andy and Alice Goulais (Denis Goulais' parents). Martha remembers that they had to work hard to survive. Her father worked at a tourist camp as a guide. He helped to start the garden in spring, but was off to work while the rest of the family were left to look after it. Tourists bought veggies from them. Martha remembers it being easy in the summer. A board would come twice weekly with groceries. You were able to buy right off the boat or order what you wanted for him to bring on his next round. If you wanted to go to town, he would also take passengers, and you would come home a day later.

Hardy Bay Fishing Club tourist camp was situated on an island about less than 1/4 mile from their house. A boat called Seagull came there daily and they used to paddle their canoe across. Martha's sister, Mary, and her brother, Joe, would sometimes swim across. Very nice childhood memories. The Seagull boat sold groceries, goodies, and brought mail. You could also order from the Eaton's catalogue. Martha remembers cutting a picture of a pair of shoes out from the catalogue that cost \$1.99, and she ordered them.

They moved down the river to Wolelsy Bay for about twelve or thirteen years. Martha, Mary, and their father worked at a lumber camp. Their father was head cook there, Mary cooked desserts, and Martha set and served the tables, and washed dishes. They worked these jobs for about one year, then her dad worked in the bush. Both Mary and Martha did laundry. This is where she met

Frank Clemens in October 1944, and they married in May of that same year. The wedding was in Noelville at St. David's church. Frank would work the lumber camp for the winter and the tourist camp for the summer. He also trapped beavers and muskrats in the spring and fall. This was done for twelve years. John, their first born, was born at St. Joseph's Hospital in North Bay. Because there was no hospital in Wolsely Bay, she stayed with her parents in North Bay until she went into labour in hospital. Martha stayed with her parents two months after the birth of John.

Martha's parents lived in Springer Township when she had Kathleen and Juliette. Martha again stayed with mom and dad until she had the girls at St. Jean de Brébeuf Hospital in Sturgeon Falls.

Frank and Martha moved to Springer in 1959, where Martha still lives today. Frank worked as a carpenter and helped build Au Château and the arena in Sturgeon Falls. Frank also built a lot of houses in Garden Village, like the late Richard Goulais, Harry Goulais, and Isidore Beaucage. He also built his own home. He was a very hard worker.

Martha always sewed her children's clothes. She tanned moose and deer hides before she married. She remembers tanning a small deer hide at the age of 14, all by herself, and was very happy to finish the project. She tanned many hides as well in her married life with Frank. He was a hunter, so the hides were always available. Martha made moccasins and mitts to sell. As the years went by, she bought the hides and did a lot of sewing.

When Martha was asked about schooling, she said she was sent to school by her parents, but the Chief would tell the Indian Agent about them and they would be sent home, because they were not status. She did enjoy attending when she did, though.

Martha's husband, Frank, was from Belgium. He came home to Canada with his family in 1919. Frank died on June 6, 1977, of cancer. Martha joined the homemakers club in 1960. She enjoyed that very much. She still sews a little, but her love is for travelling. Martha has travelled to the shrine in Midland since 1961, the days when Father Hannin planned this trip. She has not missed a year. In 1976, she started attending the tours to Montreal to visit shrines there; she has only missed four trips. Martha has been to the Holy Land four times. She has been to Egypt, Bethlehem, Nazareth, and Israel, to name but a few. She has done a fourteen-day tour of Italy, Paris, and Rome. Martha leads a quiet life. She has a growing family of grandchildren, and one great-grandchild.

DECLARATION BY VOTE OFFICER

(Conclusion of Vote)

I, Laura Commanda, Nipissing Nation Vote Officer, of Nipissing First Nation in the Province of Ontario, DO SOLEMNLY DECLARE THAT:

- I was the Vote Officer present and overseeing the Nipissing First Nation vote concerning the distribution percentages of Nipissing First Nation's portion of the Robinson Huron Treaty Settlement ("RHT vote") which were concluded and counted on April 6, 2024.
- A true copy of the Notice of Vote is attached to this Declaration which was distributed in accordance with the Nipissing First Nation's Community Vote Procedures.
- In accordance with the Nipissing First Nation Community Vote Procedures, a copy of the Notice of Vote that stated the question to the eligible voters as:

"What percentage of the Robinson Huron Treaty Past Annuity funds should be allocated to the individual and what percentage of the Robinson Huron Treaty Annuity funds should be allocated to the community fund?"

Option 1 - 65% for the individual and 35% for the collective fund. Option 2 - 75% for the individual and 25% for the collective fund.

- The voting procedures and the counting of results, were conducted in accordance with the Nipissing First Nation Community Vote Procedures.
- The number of Eligible Voters on the Voter's List was <u>2746</u>.
- 6. The number of Eligible Voters who cast their vote was 1742.
- The results of the vote are as follows:
 - a. 1742 ballots were cast in the RHT Vote;
 - b. 2 ballots were spoiled;
 - c. 16 ballots were deemed rejected;
 - d. 1639 ballots were marked 75% for the individual and 25% for the collective, for the Question; and
 - e. 85 ballots were marked 65% for the individual and 35% for the collective, for the Question.
- Option 2 75% to the individual and 25% to the collective fund was selected by the majority of the registered Nipissing First Nation Eligible Voters who cast a vote.

Spring Moratorium in Effect Until May 18, 2024

In accordance with Nipissing First Nation's Fisheries Law, the annual spring gillnet moratorium is in effect as of Monday, April 1, until the 2024 fishing season begins on Saturday, May 18, 2024. The temporary moratorium on the cultural practice of spear fishing remains in effect this year. Our enforcement officers will regularly monitor for compliance.

We offer in-person registration for commercial and subsistence fishers at the Fisheries Office, located at 17 Phillip Avenue in Garden Village. Online registration links for commercial and subsistence fishers and catch-reporting form will be posted at nfn.ca/fisheries in the near future.

Miigwech to the registered commercial fishers and community members who respect the will of the community and follow the NFN Fisheries Law. Your efforts help to ensure we can all enjoy the resources that Lake Nipissing provides for us now, and for future generations to come.

NFN plays a fundamental role in promoting the health and recovery of the Lake Nipissing fishery. NFN continues to have significant successes in protecting the lake's walleye population and maintaining safe harvest levels within our commercial fishery, consistent with Aboriginal treaty and harvesting rights.

The spring gillnet moratorium is the most important management tool we have to protect spawning fish, which allows for increased reproduction, and ensures the long-term health and sustainability of the Lake Nipissing fishery.


NFN Volunteer Appreciation dinner


